Advertising Contract Terms & Conditions:

This agreement shall be for a minimum term of one month from the effective date hereof and is renewable for one-month terms by Sun City Grand Community Association, Inc. by use of this written contract only.

Advertiser agrees to comply with all of the Association's time deadlines for delivery of the services throughout the term of this agreement. The Association may terminate all or any portion of the services by providing thirty days' written notice to the Advertiser.

All advertisements must be contracted and paid in full by the **tenth of the month** prior to the month advertising is to begin, unless the tenth day falls on a weekend, in which case the deadline will be the following Monday.

Orders must be paid by check or credit card (we accept Visa, Mastercard, Discover and American Express).

Prices are subject to change without notice. All payments are final. Listed prices include tax.

This agreement is subject to approval by an authorized representative of the Association prior to publication and will be canceled with all monies returned if advertisement is not approved.

The Association will decide where to place the advertisement within the Grand Lifestyles Magazine. If the Advertiser wants a premium location, the Association will levy a 10% Premium Placement fee on top of the total contract amount. Premium locations are defined as: inside front cover, page 3 and back cover. Premium Placement requires a 12-month prepaid contract.

10% discount is only valid for 12-month contracts. Adjustment is not reflected in above pricing and will need to be applied when contract is submitted.
